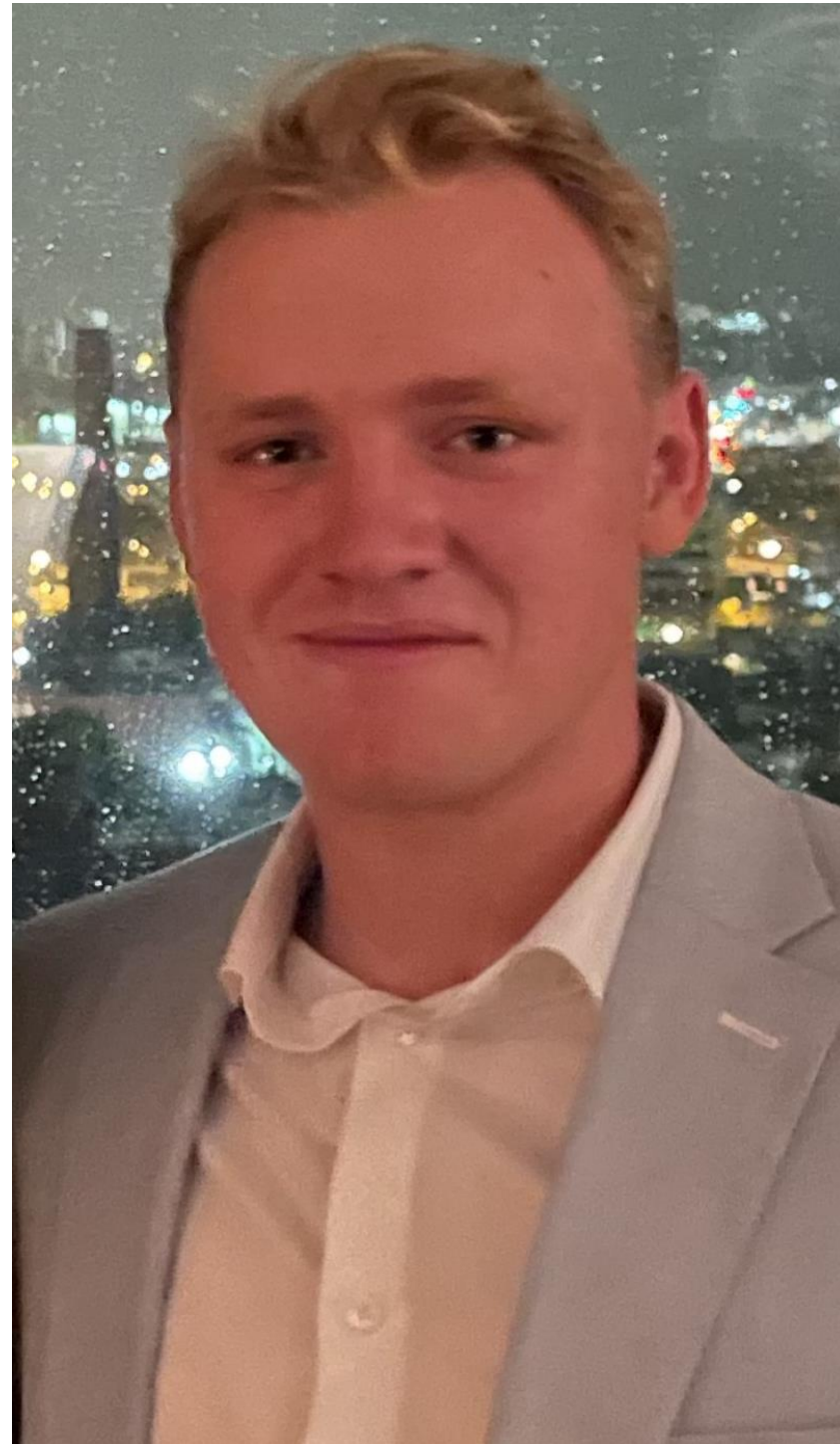
GIORGIO GAYLEARD

ANTONI JARECKI



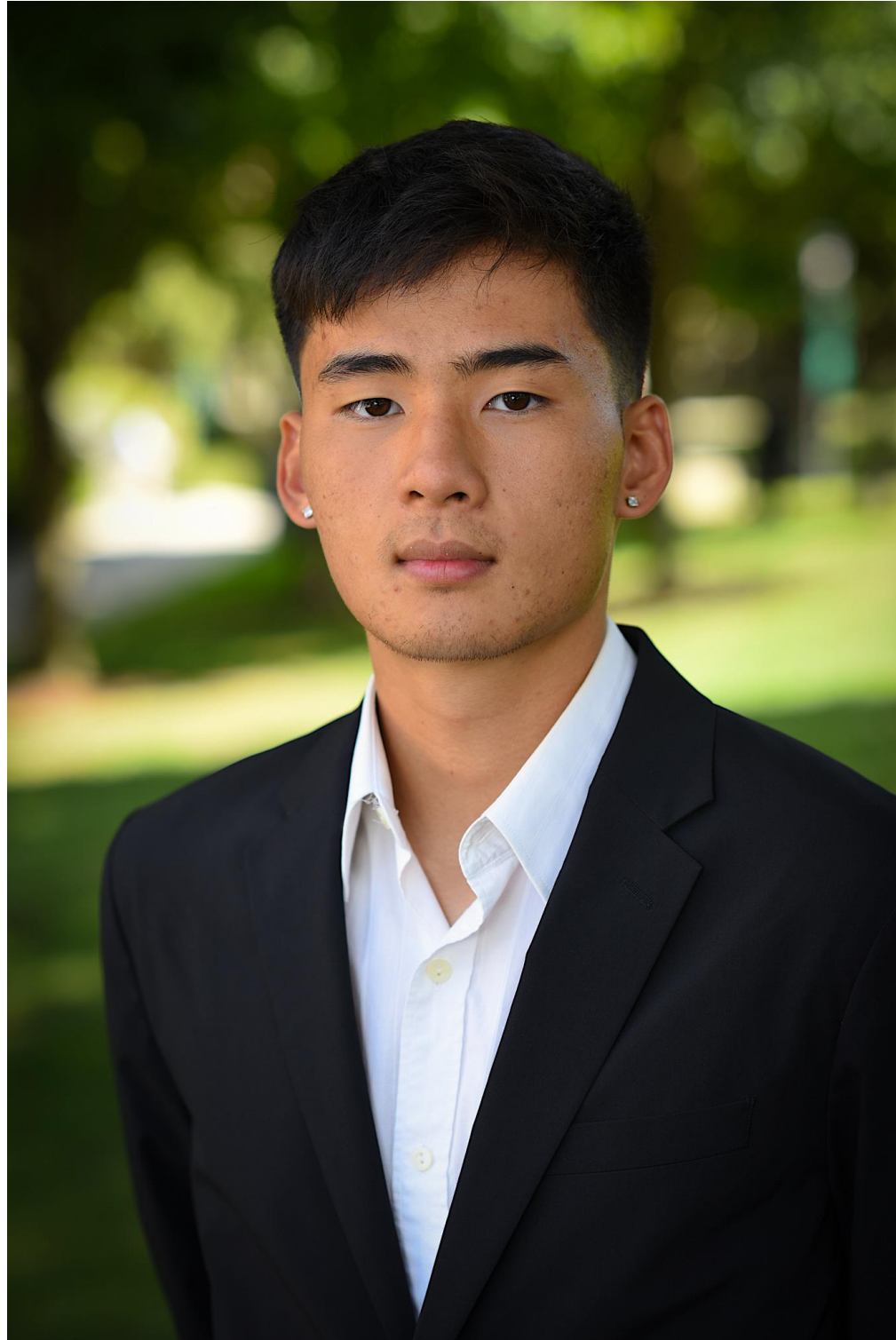
